Out-of-network providers \$6,000 individual / \$12,000 family.</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. For example: In-network preventive care, primary care, specialist, urgent care, virtual visits, outpatient behavioral health, outpatient rehabilitation and habilitation, as well as some in and out of network children vision services and adult eye exams and some prescription medications are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount.
