<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p>For <a href="#">network providers</a> \$1,000 individual / \$2,000 family; for <a href="#">out-of-network providers</a> \$3,000 individual / \$6,000 family</p>	<p>Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a>, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a>.</p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes. In-network primary care visits, office visits, urgent care visits, virtual care visits, acupuncture, spinal manipulation, massage, therapy, outpatient rehabilitation and habilitation, outpatient mental health and chemical dependency services, outpatient diagnostic x-rays and labs, breastfeeding support, pediatric dental preventive and diagnostic, and most <a href="#">preventive care</a>, as well as in and out of network emergency room care, routine nursery care, vision care, breastfeeding supplies, hearing services, and prescription drugs are covered before you meet your <a href="#">deductible</a>.</p>	<p>This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a>. <p><b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b></p>	<p>For <a href="#">network providers</a> \$7,500 individual / \$15,000 family; for <a href="#">out-of-network providers</a> \$22,500 individual / \$45,000 family</p>	<p>The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. If you have other family members in this <a href="#">plan</a>, they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket limit</a> has been met.</p>
