If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. For example: In-network preventive care, primary care, specialist, urgent care, virtual visits, outpatient mental health and substance use disorder, outpatient rehabilitation and habilitation, children vision services and adult eye exams, as well as in and out of network prescription medications are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount.
