Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	For <a href="#">network providers</a> \$100 individual / \$200 family. <a href="#">Out-of-network providers</a> are not covered.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. In- <a href="#">network preventive care</a> , primary care, <a href="#">specialist</a> , <a href="#">urgent care</a> , virtual visits, outpatient mental health and substance use disorder services, outpatient rehabilitation and habilitation, adult and children's eye exams, as well as most in and out of <a href="#">network</a> prescription medications are covered before you meet your <a href="#">deductible</a> . For <a href="#">network providers</a> \$750 individual / \$1,500 family. <a href="#">Out-of-network providers</a> are not covered.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services.
